



VOLUNTEER AND EVENT PARTICIPATION WAIVER

I, [first name, last name] _____ ("Participant") acknowledge that I have voluntarily agreed to participate in a tree climbing program where I will be in, among, and around large trees, as well as other participants, including myself, who will be climbing these large trees. By participating in this Casey Trees, Bartlett Tree Experts, and M-NCPPC (property owner) tree climbing program, the participant understands that activities of this tree climbing program will involve potentially strenuous and hazardous activities and there are risks of accidents arising out of these activities. The participant acknowledges that she/he/they has the physical capabilities reasonably necessary to engage in these activities.

The participant expressly assumes all risks of injury, bodily harm, or property damage arising out of the event with Casey Trees, Bartlett Tree Experts, and M-NCPPC, and further acknowledges that she/he/they is responsible for his/her/their own insurance coverage and that neither Casey Trees, nor any of its partners associated with this tree climbing program, shall have any liability or responsibility to the participant for any medical, health or other benefits or compensation.

The participant releases and forever discharges Casey Trees, Bartlett Tree Experts, and M-NCPPC, their successors and assigns, employees, officers, directors, volunteers, and agents, and any sponsoring organizations from any and all claims, liabilities and demands of any kind or nature, in law or equity, arising out of the participant's participation in the tree climbing program, including any claims for bodily injury, death, illness or property damage occurring while participating, in any way, in the tree climbing program, even if caused by the negligence or reckless conduct of a Casey Trees, Bartlett Tree Experts, or M-NCPPC employee or volunteer. In consideration for being allowed to participate in this tree climbing program, the participant expressly waives any and all rights she/he/they have or may have in the future to bring any lawsuit against Casey Trees, Bartlett Tree Experts, and M-NCPPC for any injury and/or damages suffered arising out of participation in the tree climbing program.

In case of emergency or accident, the participant gives permission for any first aid treatment or other medical services rendered on their behalf, and releases Casey Trees and its partners associated with this tree climbing program from any and all liability in connection with any medical services. The participant agrees to be the responsible party

for all medical expenses incurred on their behalf.

The participant grants Casey Trees, Bartlett Tree Experts, and M-NCPPC, all rights, title and interest in any photographs, images, video or other media recordings of themselves or their likeness or voice in connection with their time with the tree climbing program.

Participants agree to comply with the written instructions above and all instructions given to them by the tree climbing program staff. Failure to comply with these written instructions or verbal instructions from staff may result in being removed from events and participants may be asked to cease any further activities or opportunities on behalf of Casey Trees, Bartlett Tree Experts, and M-NCPPC.
